The purpose of processing the personal data and legal basis	<p>The personal data of shareholders and proxy representatives are processed for the purpose of organizing and appropriately documenting the Glaston Corporation's Annual General Meeting (AGM), including for example collecting registrations for the AGM, ascertaining the registrants' right to participate in the AGM, and for arranging any voting.</p> <p>The processing of personal data is based on the legal obligations regarding the AGM in the Finnish Companies Act and other legislation.</p>
4. Personal data processed	The personal data processed for the purposes set forth above includes name, personal identity number, phone number, number of bookentry account, ownership information such as number of shares and votes, as well as information on the possible authorized representative.
5. Regular information sources	<p>The personal data are as a general rule obtained from the shareholder enrolling to the AGM and/or from a party acting on their behalf.</p> <p>In addition, the provided personal data is compared with the shareholders' register of Glaston Corporation maintained by Euroclear Finland Oy, from which ownership information is retrieved.</p>

Recipients of personal data and transfers to countries outside the European Union or the European Economic Area</p>	<p>Provided personal data will be transferred to Euroclear Finland Oy to retrieve ownership information from the Glaston Corporation's shareholder register.</p> <p>Personal data may also be transferred to Castrén &amp; Snellman Attorneys Ltd for the purposes of acting as the shareholder's proxy representative. Retention period for personal data</p>	<p>The personal data is kept only as long as it is necessary for the purposes set out in this statement or to comply with the retention periods set forth in legislation.</p> <p>The retention periods mentioned herein have no effect on the retention of similar personal data for other purposes, for example as part of a list of shareholders</p>
